2023 All in for ALS VENDOR AGREEMENT



- Vendors must use the entrance marked THE STUDIO, called the “South Entrance” or THE LAB entrance and the freight elevator for load in and out. Both are located to the left of the Main Entrance. Please do NOT lean anything against elevator walls.
- In an effort to enforce this policy and maintain the Main Entrance, also the Guest Entrance, any company or individual who violates the terms of this agreement by using the Main Entrance for loading in or out will be fined \$1500.00 in order to pay for repairs to preserve the integrity of the Main Entrance. This amount will be subtracted from your invoice when applicable and/or you will be invoiced. You will not be allowed to work at The FUGE until this fine is paid.
- Vendors will coordinate their arrival time in advance with The FUGE.
- All load in and set up must be complete 1 hour prior to event start time.
- Vendors will make known, in advance, any special needs or notable set up requirements such as tables, chairs, outlets, cords, etc. Please do not expect The FUGE to have items on-hand the day of the event.
- All vendors must park around the back of The FUGE or in grass Staff-Lot. Please be respectful of the fact that there is limited parking available on premise for our mutual clients.
- All vendors must provide a Certificate of Insurance (COI) naming “The FUGE, LLC” and “Cravero Turnkey Solutions, LLC” as additional insured at: 780 Falcon Circle, Suite 201, Warminster, PA 18974. A minimum
- \$1,000,000.00 coverage is required.
- Smoking is NOT allowed anywhere inside the building. Please use designated outside areas.
- Vendors are not permitted to drink alcohol while working at The FUGE.
- Surveillance is used in certain areas of the building for The FUGE, as well as the client’s, protection.
